VORWORT

Die Hefte 38–40 der „Keilschrifttexte aus Boghazköi“ enthalten im wesentlichen Funde aus den Grabungen von Kurt Bittel in den Jahren 1932 und 1933, wobei ein umfangreiches Textensemble in Gebäude A der Königsburg freigelegt worden war. Die Tontafeln waren allerdings leider nur in stark fragmentarischem Zustand auf uns gekommen, so daß es vieler Jahre geduldiger Aufarbeitung bedurfte, um aus einem Fund von mehr als 3000 Fragmenten nach Möglichkeit größere Kontexte wiederzugewinnen.

Diese Aufgabe ist in den letzten Jahren von unserer Arbeitsstelle in Mainz intensiv aufgenommen worden und hat mit den Heften 34 und 39 der „Studien zu den Boğazköy-Texten“ für die Funde der Grabung 1931 und 1932 erste Teilergebnisse gebracht¹. Die Arbeit wird fortgesetzt, und so konnte für die „Inhaltsübersicht“ von KBo 38 mit Textfunden aus der Grabung von 1933 bereits dankbar auf die Ordnung und Joinzusammenstellungen von Dr. Silvin Kořak in seinen Manuskripten für Konkordanz III und IV zurückgegriffen werden.

Die Autographien des vorliegenden Heftes sind von den beiden Autoren während der letzten Jahre im Anadolu Medeniyetleri Müzesi in Ankara angefertigt worden²; für die Möglichkeit einiger weiterer Kollationen und Korrekturen haben wir dabei der Deutschen Forschungsgemeinschaft Dank zu sagen, die mit einer Sachbeihilfe Reise und Aufenthalt im Sommer 1995 ermöglicht hat. – Das Deutsche Archäologische Institut konnte uns auch dieses Jahr, leider wohl letztmalig, Unterkunft und Arbeitsmöglichkeit (mit Bibliothek) in seiner Zweigstelle bieten. Es war dies für die laufende Aufarbeitung der Boğazköy-Texte eine ganz wesentliche Hilfe.

Insbesondere haben wir aber den türkischen Stellen, namentlich Herrn İlhan Temizsoy, Direktor des Anadolu Medeniyetleri Müzesi, und den Kustodinnen der Keilschriftlichen Textsammlung unseren verbindlichen Dank auszusprechen für stets freundlich gebotene Hilfe während vieler Wochen der Arbeit an den Originalen.
